### Eligibility:

- \*Members of the Printmakers of Cape Cod and the Gallery Artists of SSAC.
- \*Works must be in printmaking media (combinations of methods and mixed media within the transfer of images acceptable).
- \*Artists should approach the topic of *“Botanicals Reinterpreted”* as “any of or relating to plants, specimens of growth...” in any manner they may wish to interpret.
- \*The juror may reject any image that does not fit the criteria for the show.
- \*Works must be for sale and may not be removed prior to the conclusion of the exhibit.

### Entry Procedures:

- \*Email Entries must be accompanied by the following information:  
Artist name, Title, Media, Price, Framed Dimensions
- \*Entry for 1 piece \$15, 2 pieces: \$20.00  
Entry Fee should be sent by check made out to: **Printmakers of Cape Cod,**  
Accompanied by Artists Statement of less than 200 words  
Titles of works submitted.

## **Framing and Size Requirements:**

Work must be ready to hang with a wire or if a pedestal, display requirements should be cleared with Karen Pinard. There is a size limit of 36 inches in width. All work must be framed with **narrow silver or black frames**. The gallery director may refuse to install work not presented in a professional manner or differs significantly from the digital image presented to juror.

## **Juror: Mary Moquin**

Mary Moquin is a Past President of Printmakers of Cape Cod and holds a BFA in printmaking and an MFA in painting. Her work has been exhibited in regional and international shows. Her work is currently on view at Cove Gallery in Wellfleet and Chapman Gallery in Cotuit. Mary teaches various classes and workshops in painting and printmaking.

## **Publicity:**

SSAC will do the publicity and reception for the exhibition. Each artist grants consent for use of submitted images for publicity or reproduction for educational purposes.

## **Sale of Art Work:**

Works will be sold through the offices of South Shore Art Center. The center will take a 40% commission
